**PURPOSE**: To understand a nation's present, it is essential to understand its past. Students completing this course will have a far better understanding of America's social, economic and political structure. Strengths and weaknesses of the United States will be put into perspective. Beyond subject matter, a study of history will help any student to improve analytical skills because of the necessity of identifying what is important out of a large amount of data. Like any subject in the liberal arts, history teaches the student how to learn.

**COURSE DESCRIPTION:** The course covers the period 1865 (the end of the American Civil War) to the present. Examine major themes including the impact of industrialization, the growth of multi-ethnic America, racial relations, changing gender roles, the rise of the United States to a position of world power and the future place of America in the world community. Students will be encouraged to cultivate good note-taking skills and to approach complex subjects analytically. (3 units)

**STUDENT RESPONSIBILITIES:** There are no requirements for this class. Students must keep up with the readings and take accurate notes. The text is T. Bailey & David Kennedy *The American Pageant*: Brief Edition, Volume II. (Look for older edition available used on Amazon.
