BA 43 – MANAGERIAL ACCOUNTING

COURSE DESCRIPTION

Emphasis in this broad-based course is on imparting to the student an increased knowledge and understanding of the role of management control in the modern multiplan organization, as well as the development of skills to be used throughout the cycles of a business in solving managerial control problems.

REQUIRED TEXT AND MATERIALS

1. Introduction to Management Accounting, Horngren, Sundem and Stratton, 14th Edition. Note you must have the text that is 17 chapters and <u>not</u> the 14 chapter text. Order these this text as soon as possible as we will start using in class two and an assignment will be due in week three.

TEACHING STRATEGY

We will cover the material in the course with lectures, discussions, classroom work, case analyses and out of class assignments. In class, we will focus on conceptual and numerical issues, and I expect you to pick up the descriptive material from your readings. Reading the chapters ahead of class will help you to ask good questions, and make it easier for you to work on the problems and participate in class discussions. TERM PROJECT - Presentations and Reports

Each student will generate a presentation using power point slides. Please limit your power point presentation to a maximum of 6 slides.

The presentation should be about a company's suitability for investment. Identify information that would be important to potential investors. The presentation should include information from financial statements and various financial analyses. The analysis should be based on information from the most recent public information (annual reports, 10K and analysts etc.). Determine if the company would be worthy of your recommendation as an investment. This recommendation should be accompanied by supporting information.

You should be able to find financial information in various financial websites like Yahoo or Google Finance. Following is an outline of a possible presentation:

- Overview of firm
- Summary of key financial information from Income Statement and Balance Sheet
- Key accounting information and disclosures
- Analysis of its financial performance
- Summary of findings
- Recommendation of investment potential
